The People's Choice meat will be handed out after the cook's meeting on Friday. If you are not able to make it in time for the cook's meeting, it is your responsibility to arrange pickup of the People's Choice meat. We will have a volunteer going around and picking up the cooked product for the People's Choice. We will have an area set up for the public to try all the different ribs and they will vote for the top 3. We will be paying the top 3 finishers. All Pro and Backyard Competitors are eligible to compete in People's Choice ribs contest.

The highest average score is the winning metro.
